BSCC lands the cable at the Ngeremlengui Cable Landing Station, known as the Capacity Access Point at Ngeremlengui (CAP-N). In addition to the PC1, BSCC builds the Palau Cable 2 as a branch to the Echo subsea cable with direct connections to Singapore and the mainland United States. This initial section of cable will ultimately be connected to the ECHO submarine cable system, connecting Singapore to the United. The Belau Submarine Cable Corporation is a state-owned public corporation that owns and manages a submarine fiber optic cable network for the Republic of Palau.
